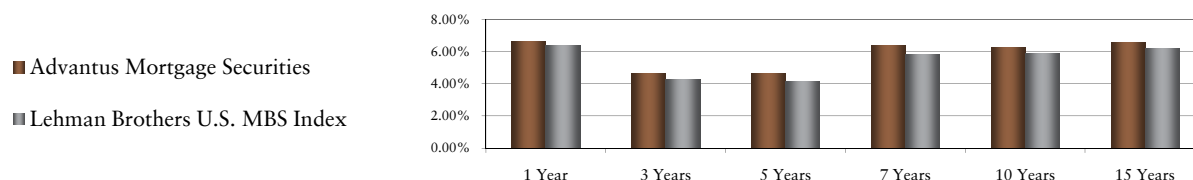

(the Firm) is a wholly-owned subsidiary of Securian Financial Group, Inc., the parent company of Minnesota Life Insurance Company, and relies on the separately registered entity to establish the Firm. The composite consists of all fully discretionary, fee-paying accounts greater than \$20 million, currently three registered investment companies, managed in a mortgage security fixed income style. Prior to July 1, 2004, all accounts greater than \$4 million are included in the composite. The Mortgage Securities Fixed Income composite focuses on mortgage-related securities. A major portion of its assets are in investment-grade securities representing interests in pools of mortgage loans. It also may invest in a variety of other mortgage-related securities. The style involves the active management of security selection, portfolio duration, structure, and sector allocation; and is managed against the Lehman Brothers U.S. MBS Index. The Lehman Brothers U.S. MBS Index is an unmanaged list of investment grade mortgage securities and does not include trading or management costs. This benchmark is frequently used as a measure of market performance and is not necessarily substantially similar to the composition of the Firm's Mortgage Securities Fixed Income accounts. Account performance is calculated in U.S. dollars on a time-weighted basis. Composite returns are asset-weighted using beginning-of-month market values. Annual returns are derived from the geometric linking of monthly returns. The composite dispersion is the asset-weighted standard deviation of gross annual returns for accounts in the composite the entire year. The composite creation date is June 30, 1998, the date that historical information was first compiled. The inception date of the composite style is January 1, 1987. Additional information regarding policies for calculating and reporting returns is available upon request.

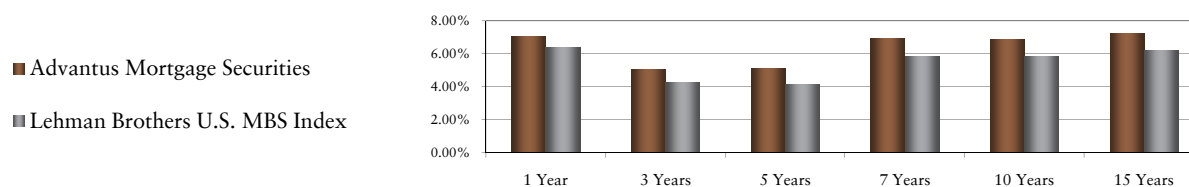
The Firm's current annual fee schedule for mortgage securities fixed income institutional accounts is generally 0.35% on the first \$25 million invested, 0.25% on the next \$75 million, and 0.20% on the balance. All accounts within the composite are fee-paying. Composite net performance is calculated using the weighted average annual fee for each month. This fee is a weighted average of the actual fees paid by each account within the composite. Different types of accounts pay different levels of fees. Therefore, the institutional fee schedule provided will most likely represent a different fee schedule than the weighted average fee used to calculate the performance figures shown. The weighted average annual fee for the most recent one year period is 0.41%. Performance results include the cost of brokerage commissions, management fees, and custodial fees, but exclude the impact of income taxes, which, if included, would reduce the overall performance. Investment transactions are recorded on trade date. Investment income is included on an accrual basis. Account assets include cash and cash equivalents. A complete list and description of the Firm's composites and performance is available upon request. As of March 2005, the Firm made nonmaterial revisions to the Total Firm Assets information included in this composite for the years 1995, 1996, and 1998-2002, to reflect the inclusion of sub-advised and non-security assets, such as direct mortgage loan and real estate investments, in accordance with the Global Investment Performance Standards (GIPS®). These revisions did not affect performance information included in this composite. Past performance is not indicative of future results. An independent public accounting firm has completed a verification of Advantus Capital Management, Inc. for the ten years ended December 31, 2006. In addition to the firmwide verification, a performance examination of the Advantus Mortgage Securities Fixed Income Composite was performed for the thirteen years ended December 31, 2002.

Advantus Capital Management, Inc. (the Firm), is a wholly-owned subsidiary of Securitan Financial Group, Inc., the parent company of Minnesota Life Insurance Company, and relies on the separately registered entity to establish the Firm.

The composite consists of all fully discretionary, fee-paying accounts greater than \$20 million, currently three registered investment companies, managed in a mortgage security fixed income style. Prior to July 1, 2004, all accounts greater than \$4 million are included in the composite. The Mortgage Securities Fixed Income composite focuses on mortgage-related securities. A major portion of its assets are in investment-grade securities representing interests in pools of mortgage loans. It also may invest in a variety of other mortgage-related securities. The style involves the active management of security selection, portfolio duration, structure, and sector allocation; and is managed against the Lehman Brothers U.S. MBS Index.
